Wisconsin Avenue Update

Visit the ANBA website at www.appletonnorthsidebusiness.com to download a document called "Traffic special provisions.pdf". This pdf contains the traffic section of the special provisions that the contractor will be expected to follow. Read through the detailed document and if something doesn't make sense or if you would like to talk about it, give Mark a call at 920-832-6486.

We are expecting the Wisconsin Avenue project to start around April 1, 2011. Stage 1A and 1B should be complete near the end of July. Stage 2 should be complete by the end of October 2011.

Stage 1A: Reconstruct the segment of STH 96 from the west construction limits to approximate sta. 229+50 (west of Morrison Street). Coordinate necessary traffic signal operation changes with the City of Appleton Traffic Engineer.

Stage 1B: Reconstruct the segment of STH 96 from approximate sta. 264+00 to the east construction limits. This segment may be constructed concurrently with Stage 1A.

Stage 2: Reconstruct the segment of STH 96 from approximate sta. 229+50 to sta. 264+00. See Prosecution and Progress section of pdf for when work can begin on this stage.

Also, there are two other projects near Wisconsin Avenue next year. Brewster from Clark to Oneida will have underground sewer and water work. This project will not start until Stage 1A is complete. Woodland Avenue from Viola to Kenilworth will have new asphalt pavement placed.
